Most people have not heard of neurofibromatosis (NF), even though it is a condition that affects approximately 1 in 2,500 people and is more common than cystic fibrosis, muscular dystrophy, and Tay-Sachs COMBINED. It is a genetic disorder of the nervous system that causes tumors to form on the nerves anywhere in the body at any time. NF can cause cancer, hearing loss, learning disabilities, epilepsy, bone deformities, vision impairment, chronic pain and more. There is no cure...YET!

The monies raised in these walks are used to fund research, improve clinical care and for programs of support and education. Due to the nature of NF, research benefits more than just those affected by Neurofibromatosis. NF studies have already greatly advanced research in many types of cancer, learning disabilities and other areas.

Start Time: Check-in starts at 9:00 a.m. The walk begins at 10:00.

Cost: Advance registration is \$20 per person age 11 and up or \$25 the day of the event. Children 4-10 are \$12 and children 3 & under are free. Each person who raises over \$100 will have their registration fee waived. All participants registered by April 7 are guaranteed a free t-shirt.
